# India drub Nepal to clinch SAFF football for 8th time

## Chhetri on par with Messi with 80 international goals

Male, Oct 17: Talismanic Sunil Chhetri equalled the iconic Lionel Messi with his 80th international strike as an inspired India blanked Nepal 3-0 for their eighth SAFF Championship title here on Saturday.

India extended their domination in the regional tournament thanks to second half goals from Chhetri (49th minute), Suresh Singh (50th) and Sahal Abdul Samad (90th).

With his strike, the 37-year-old Chhetri equalled Messi and became the second highest goal-scorer in international football among active players.

Suresh Singh and Saha then added to the tally and paved the way for India's title triumph, a much-needed one after a series of mediocre

outings. Sahal made it 3-0 when he dribbled past a few defenders after receiving the ball on the left flank at the stroke of the final whistle.

India dominated possession in the first-half but failed to break the deadlock. However, Chhetri put India ahead minutes into the second half and even before Nepal could down settle down, Suresh made it 2-0.

This is the Indian football team's first title triumph under head coach Igor Stimac, who faced criticism in recent times for his side's inability to win enough games.

However, when it mattered the most in this edition of the regional tournament, Stimac's players delivered the results the team's fans had been waiting for.

Stimac also became the third foreign coach after Jiri Pesek (1993) and Stephen Constantine (2015) to clinch the title with the Indian team.

Chhetri gave India the lead after he charged in to neatly head in a delivery from Pritam Kotal on the right flank, leaving the Nepalese goalkeeper with no chance to come to his team's rescue.

Barely a minute after Chhetri's opener, another attack by India caught Nepal completely off-guard as Suresh found the back of the net after Yasir Mohammad brilliantly cut it back for the mid-fielder.

Their tails up after two quick strikes, India pressed hard for more but could not add to the tally for a while before Sahal found the back of the net with his solo effort.

# A tough call to omit Chahal for Chahar: Kohli

Dubai, Oct 17: India captain Virat Kohli on Saturday admitted that dropping a proven performer like Yuzvendra Chahal was a tough call but the Haryana leg-spinner's lack of pace off the surface on the slow UAE tracks tilted the scales in favour of the quicker Rahul Chahal.

Rajasthan's Chahal picked up 13 wickets from 11 games in this

edition of IPL for Mumbai Indians but was benched during the end stage. Chahal, with 18 wickets in 15 games, was the second highest wicket-taker in the RCB team behind Harshal Patel's 32 scalps.

"It was a challenging call but we decided to back Rahul Chahal for a reason that he has bowled amazingly well in the last couple of seasons and a guy who bowls with pace," Kohli

said at the ICC captain's press conference ahead of the T20 World Cup.

The skipper reiterated that Chahal's consistency over a period of time was taken into consideration during the selection meeting for picking the team.

"Rahul did really well in Sri Lanka and against England at home as well. He was someone who bowled those difficult overs," he said and then explained

the rationale.

"We believe getting into the tournament, wickets will be getting slower and slower. Guys who bowl with a lot more pace as you saw in the later stages of the tournament as well, were the ones who were able to trouble the batters and probably not give the ball too much air." These are strengths that make Chahal a wicket-taking candidate, he said.
